CODE OF CONDUCT: NATIONAL TEAM MEMBERS

This code of conduct is developed to ensure the enjoyment of all team members whilst representing SANSSU at the highest level. It establishes expectations and obligations in advance, and all team members, as well as their parents or guardians, are required to sign it and submit by the deadline set by Team Management.

I _____ (name of Shooter) agree to abide by the following code of conduct whilst representing SANSSU at the _____ (name of event):

1. Every team member is at all times under the direct control and supervision of the team management and any duly delegated representative(s) of the team management.

Elke spanlid is ten alle tye onder die direkte beheer en toesig van die toerbestuur en enige gedelegeerde verteenwoordiges van die bestuur.

2. Team members may not leave the group for any activity without the express permission of the team management or any delegated representative(s) of the team management.

Span lede mag nie die toergroep verlaat vir enige aktiwiteit sonder die direkte toestemming van die toerbestuur of hulle gedelegeerde verteenwoordiges nie.

3. All team members must at all times show courtesy towards team members, opponents and officials involved in the competition, acknowledging that each team member is a representative of our country and our community.

Alle spanlede moet ten alle tye beleefdheid toon aan spanlede, ander mededingers en die beamptes wat betrokke is in die kompetisie. Onthou ons is almal ambassadeurs vir ons land en ons mense.

4. Every team member is subject to the rules and regulations of their provincial, team sport codes as well as school regulations, where these do not conflict with the regulations as stipulated by team management.

Elke spanlid is onderworpe aan die reëls en regulasies van hul provinsiale en span sportkodes en aan hul skoolregulasies waar dit nie teenstrydig is met die toerbestuur regulasies nie.

5. Team Management and their delegated representative(s) act “in loco parentis” and accept responsibility for this.

Spanbestuur en hul gedelegeerde verteenwoordigers tree op “ in loco parents”. Hulle aanvaar alle aanspreeklikheid daarvoor.

6. Any property or premises that are damaged by a team member while on tour, will be for that team members own account.

Enige eiendom of perseel wat beskadig word deur 'n lid op toer, sal vir die skut se rekening wees.

7. Any costs not expressly mentioned or addressed in team communication, be it letters, emails, faxes or other communication, will be for the team members own account. This includes overweight baggage costs as charged by the airline.

Enige onkoste wat nie spesifiek gedek is deur die briewe, e-pos, fakse of ander notas vanaf die toerbestuur word deur die lid gedra. Hierdie reëls sluit in vlieg-oorgewig onkoste teen huidige tariewe per kilogram soos deur die lugdiens bepaal.

8. All Team Members will at all times comply with the dress code specified by the Team Management, as well as with the SANSSU policy “Performance Recognition and Outfitting”.

Alle spanlede is onderworpe aan die dragkode soos neergelê deur die spanbestuur. Die riglyne van die beleidsdokument van SANSSU “Performance Recognition and Outfitting” moet gevolg word.

9. No shooter may have in his/her possession a weapon or live ammunition without the express permission of the team management or event officials.

Geen skut mag enige wapen of lewendige ammunisie in besit hê sonder die toestemming van die spanbestuur of skietbeampes nie.

10. Each shooter is responsible for his/her own weapon(s) and to ensure that any weapon(s) are in good condition for competition. Each shooter is responsible for the maintenance of his/her own weapon.

Elke skut is verantwoordelik om te sorg dat sy/haar wapen in goeie en diensbare toestand is vir kompetisies. Elke skut is verantwoordelik vir die instandhouding van sy/haar eie wapen.

11. No team member may have in his/her possession any alcohol or narcotic substances, or make use of these.

Geen lid mag alkohol of enige narkotiese middels in sy/haar besit hê of gebruik nie.

12. Every team members is required to abide by the rules and regulations regarding drug-free-sport, as defined by WADA and the ISSF. If a shooter is taking medication, he/she should ensure that the medication does not contain banned substances, and all medication is to be declared to the team management prior to the team’s departure.

Elke spanlid moet bewus wees van die regulasies van dwelmvrye sport soos neergelê deur WADA en die ISSF. Geen medikasie mag verbode middels bevat nie en alle medikasie moet verklaar word aan die spanbestuur voor vertrek na enige kompetisie.

13. Parents wishing to attend an international event, are regarded by SANSSU and team management as spectators and will enjoy no team rights. They are not to interfere with the team or team management.

Saamreisende ouers na Internasionale kompetisies sal gesien word as toeskouers en mag op geen manier inmeng met enige besluite wat deur die spanbestuur geneem word nie.

14. Any shooter who does not comply with these rules can be summarily sent home, at his/her own cost. The parents and/or legal guardians as well as the President of SANSSU, will be informed of this decision with immediate effect.

Enige lid wat hierdie reëls oortree mag sumier en op eie onkoste teruggestuur word. Die ouers / wettige voogdes en SA Skole Luggeweer insluitende SANSSU sal dadelik in kennis gestel word indien so iets gebeur.

15. Any team member who is sent home will be stripped of national colours. Any costs associated with this will be for the shooters own account.

Enige lid wie sumier en op eie onkoste teruggestuur word, sal van sy/haar SA Skole Luggeweer kleure onthef word. Die kostes verbonde aan die kleure is dan die skut se verlies.
